- 6. The incumbent will have to abide by the rules of higher education and other terms and conditions set by the Government currently or in future.
- 7. The incumbent will leave Dhaka for Germany on 20 October 2018 or near to the date and leave Germany for Bangladesh on 19 April 2022 or near to the date.
